The Michigan City Park and Recreation Board met in regular session on Wednesday, August 16, 2017 at the hour of 5:00 P.M. in the Council Chambers at City Hall, City of Michigan City, Indiana.

The Pledge of Allegiance was recited.

On the call of the roll, the following Board Members were found to be present or absent:

 On a motion made by Mr. Silvestri, seconded by Mr. Latchford and voted for unanimously by the Board, the Board approved the minutes of the August 2, 2017 Park Board meeting.

Vice President Freese asked if there were any bids to be submitted for the Old Lighthouse Museum Exterior Repairs Project. There were no submissions and Vice President Freese closed the submission period.
